## A special delivery in Mansfield

Methodist Health System Foundation celebrated the official opening of the newly expanded Methodist Mansfield Women's Pavilion by hosting a reception at the hospital on Tuesday, Feb. 7. Donors, community leaders, and elected officials from Mansfield and surrounding communities were honored at the event.

In March 2011, Methodist Mansfield Medical Center began construction on this extensive \$9.1 million project to ensure that new moms in southeast Tarrant County could deliver their newborns close to home. In response to this need for increased labor and delivery services, the Foundation launched its first capital campaign at Methodist

Mansfield in June 2011 with a goal to raise \$500,000 from philanthropic support.

Foundation President and CEO April Box Chamberlain, CFRE, thanked the Mansfield community for its support and recognized the major donors to the Women's Pavilion Expansion campaign. Rob Schulz, chairman of the capital campaign committee, expressed appreciation to committee members for exceeding their goal by more than 60 percent, raising more than \$800,000 for the expansion.

"I feel like this expansion is one that's going to catapult Methodist Mansfield into a completely different dimension," Schulz says.


